HPCSA ROUTINE INSPECTION UNCOVERS ILLEGAL DENTAL ASSISTANT

Pretoria – The Health Professions Council of South Africa's (HPCSA) Inspectorate Office uncovered an unregistered practitioner who was practising whilst not registered with Council.

During a routine inspection at a medical practice in Lonehill, Johannesburg, the Inspectorate Office found t Ms Dorothy Shunmugam practising as a Dental Assistant despite her registration being erased from the HPCSA register in 2006 due to non-payment of annual fees.

Ms Shunmugam has been arrested and detained at Douglasdale SAPS for contravening Section 17(1) of the Health Professions Act as it is a criminal offence to practise whilst not registered with Council. She was employed by Dr Kow-Der Yeh, a registered Dentist since 2019. Dr Yeh will be reported to the Medical and Dental Professions Board for the illegal employment of an individual whose registration with Council was erased.

Practitioners registered with Council are encouraged to ensure that they vet the practitioners that they employ to ensure the safety of the public. It is illegal to employ unregistered persons and allow them to treat patients without being registered.
